

# **GOLDEN TICKET CONTEST REGULATIONS - 30th ANNIVERSARY FOXTOWN FACTORY STORES**

## **1. Contest Organizer**

## **2. Contest Duration**

The contest runs from Friday, November 7 to Sunday, November 30, 2025. The draw for the 30 (thirty) winners will take place on Sunday, November 30, 2025, at 5:00 p.m. at FoxTown, during the closing weekend celebrations of the Center's 30th anniversary.

## **3. How to Participate**

To participate, it is necessary to make a purchase of at least CHF 100.- (on a single, non-cumulative receipt) at any FoxTown store, bar, or restaurant, or purchase entry tickets to The Sense Gallery. The corresponding receipt must be presented at the InfoPoint (Level 1 central mall or Level 1 new wing near "The Sense Gallery") or, when active, at the dedicated desk, to receive one (1) Golden Ticket between Friday, November 7 and Sunday, November 30, 2025. Each receipt will be stamped upon submission. Copies of receipts will not be accepted for ticket collection. Golden Tickets can only be claimed on the same day as the purchase date, no later than November 30, 2025 (ticket collection closes at 4:00 p.m.).

## **4. Eligibility Criteria**

Participation is open only to individuals aged 18 or older as of the contest start date, that is, November 7, 2025. Employees of Tarchini FoxTown SA are excluded from participation.

## **5. Prizes**

A total of 30 (thirty) winners will be awarded shopping vouchers, redeemable exclusively at FoxTown Factory Stores Mendrisio:

1° prize: CHF 10'000.-  
2° prize: CHF 5'000.-  
3° prize: CHF 3'000.-  
4° - 5° prize: CHF 2'000.-  
6° - 10° prize: CHF 1'000.-  
11° - 20° prize: CHF 500.-  
21° - 30° prize: CHF 300.-

Total prize value: CHF 35'000.-  
No cash alternatives will be provided.

## **6. Prize Redemption Period**

Vouchers are issued in denominations of CHF 50.- each, are non-convertible into cash, and must be used in a single transaction (no change will be given). Vouchers are valid until December 31, 2026.

## **7. Tax Obligations**

According to Swiss federal law, prizes with a value below CHF 1'100.- are not subject to withholding tax; however, the winner remains responsible for declaring any winnings in their personal tax declaration. For prizes exceeding CHF 1'100.- consisting of shopping vouchers and considered as benefits in kind, FoxTown is required to notify the win (without deduction of withholding tax) to the Federal Tax Administration (FTA) using form 122, within 90 days from the date of award, attaching a valid certificate of residence of the winner.

## **8. Winner Selection**

The draw for the 30 (thirty) winners will take place on Sunday, November 30, 2025 at 5:00 p.m. at FoxTown, broadcast live on social media and radio. Each winner will be selected by random draw among the holders of the issued Golden Tickets, in the presence of a FoxTown management representative who ensures the randomness of the drawing process.

## **9. Winner Announcement**

Winning ticket numbers will be published on FoxTown's social media, website, and app, and displayed at the InfoPoints starting from Monday, December 1, 2025, until February 28, 2026. No personal correspondence will be initiated, as FoxTown does not collect any participant's personal data.

Prizes can be collected from December 3, 2025, to February 28, 2026, at FoxTown Management Offices (open Monday–Friday, 11:00 a.m.–6:00 p.m.), by presenting the physical Golden Ticket and a valid ID.

FoxTown reserves the right to exclude participants in case of suspected or proven fraud or rule violations, or for other serious reasons. Prizes must be claimed no later than February 28, 2026; after this date, unclaimed prizes will be forfeited, and Tarchini FoxTown SA may donate the equivalent value to charitable organizations. Any complaints or disputes may be submitted to Tarchini FoxTown SA no later than February 28, 2026, and will be decided in a final and non-appealable manner by the Management of Tarchini FoxTown SA.

## **10. Prize Transferability**

The shopping vouchers corresponding to the prize value are non-nominal. Once delivered, if the vouchers are lost, damaged, or unclaimed, FoxTown will not issue replacements or refunds. Legal recourse is excluded.

FoxTown will obtain the personal data only of the winners upon prize collection, when a valid ID is required. These data will be used solely for prize management and delivery purposes and will not be used for other purposes. They will be retained only as long as necessary to fulfill administrative and tax obligations.
